WHEREAS, the Citizens for Tax Reform and others are endorsing proposals to amend the Ohio Constitution to institute tax and expenditure limitations at the state and local levels of government that could only be overridden by a popular vote, and WHEREAS, such a proposal would reduce funding for education, health care, police, fire protection, libraries, economic development, and other vital services to citizens, and WHEREAS, such proposals tie the hands of state and local leaders in times of crisis and other unpredictable circumstances, circumventing state and local governments' thoughtful consideration of policy decisions, and

WHEREAS, such a proposal could undercut some constitutional provisions requiring state support of education, and

WHEREAS, such proposals would prevent state and local officials from making the tough decisions they were elected to make, passing the responsibility for learning all aspects of often complex issues to citizens who have other jobs and responsibilities, and

WHEREAS, such proposals would force the State and local governments to spend valuable time and money asking for permission from the same people who elected them before any action can be taken on important issues, and would also force taxpayers to pay twice for governance – once for elections of their state and local officials, and again for elections to make the decisions those officials should have made, and

WHEREAS, those states that have instituted similar Constitutional proposals, such as Colorado, now face severe problems in meeting the basic needs of their citizenry and are seeking to overturn key aspects of the law.

NOW THEREFORE BE IT RESOLVED that the Board of Lake Township Trustees does hereby, for all of the foregoing reasons, oppose the proposed Constitutional amendment for Tax Reform referred to as Tax & Expenditure Limits (TEL) or so-called "Taxpayers Bill of Rights" (TABOR), and

BE IT FURTHER RESOLVED that the Board of Lake Township Trustees will work to defeat the proposed amendment by allowing our name to be used in a list of coalition members of the Coalition for Ohio's Future, which organization is diligently working towards the defeat of this constitutional amendment. WHEREAS, A Board of Township Trustees is permitted under Section 955.221 of the Ohio Revised Code to adopt a resolution concerning the ownership, keeping or harboring of dogs, the restraint of dogs, dogs as a public nuisance and dogs as a threat to public health, safety and welfare, except when engaged in the field of hunting or training for hunting and when the County Commissioners have not adopted resolutions to control dogs within the unincorporated areas of the county; and

WHEREAS, The Stark County Board of Commissioners has not adopted any resolution or regulations to control dogs within the unincorporated areas of the county under Section 955.221 of the Ohio Revised Code; and

WHEREAS, this Board has determined that the persons who permit dogs to bark, yowl, or yelp for continuous periods of time are causing annoyance and disturbance to residents of the unincorporated areas of the Township and such dogs are a public nuisance and are a threat to public health, safety and welfare. NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees for Lake Township, Stark County, Ohio, hereby adopts the following resolution effective April 13, 2006:

1. No person shall keep or harbor any dog within the unincorporated areas of Lake Township which, by frequent and habitual barking, yowling or yelping, creates unreasonable loud and disturbing noises of such a character, intensity and duration as to disturb the public health, safety and welfare of the Township.

2. The keeping or harboring of a dog shall include any person who allows the dog to habitually remain, lodge, or feed within any dwelling, building, yard or enclosure which the person owns, occupies, leases or rents.

3. The frequent and habitual barking, howling or yelping of a dog shall be defined as any continuous period of time which exceeds fifteen (15) minutes in duration during the nighttime hours or thirty (30) minutes in duration during the daytime hours.

4. This prohibition shall not apply to the use of any dog that is lawfully engaged in hunting or training for hunting when accompanied by a licensed hunter. However, such dogs at all times and in all other respects shall be subject to this resolution, unless actually in the field and engaged in hunting or in legitimate training for such purposes.

5. Whoever violates this resolution in guilty of a minor misdemeanor. Each day of continued violation constitutes a separate offense. Fines levied and collected for violation of this resolution shall be distributed by the Clerk of Canton Municipal Court in accordance with Section 1901.31(F) of the Ohio Revised Code, to the treasury of Lake Township, all as provided in Section 955.99(I) of the Ohio Revised Code.

6. A copy of this resolution shall be certified by the Lake Township Fiscal Officer to the Clerk of Canton Municipal Court.
