• <u>*Tom Renner, 3119 Picardy Circle, Uniontown*</u>: Addressed the Board and asked the Board to be more specific as to what is meant by Work Related Community Service with reference to Correspondence No. 3?

Board advised Mr. Renner to attend the dinner and ask this question to the Chamber of Commerce.

• <u>Elena Ispas, 3006 Pontius Road, Uniontown</u>: Addressed the Board with sent May 6, 2006 sent package with letters regarding dog resolution. She has not heard any response from the Board and did not receive a letter in response.

Mr. Erb advised that he wasn't aware she wanted a written response, but that he has listened to the tape she sent. Indicated that he could hear the dog bark/breathe at the same time and finds that difficult to do being 50' away as indicated by her on her tape.

Mrs. Ispas explained that she had the tape set on voice activated and put it on the 6' high fence which was approximately 10' away from the dogs and she herself was 50' away. She indicated that regardless of where the tape was, she feels she should have received an answer to her complaint. She noted that there are other dogs in the neighborhood that do not bark and cause a disturbance in the neighborhood. She noted that whenever the dogs hear her in her back yard, they bark and cannot be outside without them barking. She would like the Board to amend the current resolution so that it doesn't have to be 30 minutes of continual barking.

Mr. Erb advised that technically we cannot legally fully enforce the resolution anyway and that Cities have more authority with reference to these issues. He advised that we have to follow the laws of the Ohio Revised Code and that we are not a Home-Rule Township, we are limited in what we can do.

Mrs. Ispas questioned why the Board passed this Resolution then? Mr. Erb explained that it was in order to help a little bit in the situation to the best of the Township's ability based on the authority given to us by the Ohio Revised Code.

Mrs. Ispas asked Mr. Erb to please send his response that he gave tonight in writing.

Mr. Erb questioned why she needs a letter as she was told everything tonight? He said that the Board will send her a simple letter explaining why they are limited and why they cannot handle this any better -- because the Township is not Home Rule.

Mrs. Ispas explained that the dogs are harassing because they don't bark unless she's outside and she cannot enjoy being in her backyard because of them.
