• The Board discussed the salary continuation proposal for Officer Brian Duman. Trustee Arnold explained that the injured employee will get paid either way, it is just a matter of the form of compensation he will receive. Either the township continues to pay him which keeps our workers compensation premiums and group rating down or the employee applies for workers compensation possibly causing the premiums and rating to go up. Trustee Arnold commented that it is not financially advantageous either way.

Trustee Yoder stated that he is leaning towards having the employee apply for workers compensation. Trustee Miller said that he will vote to have the employee apply for workers compensation. Trustee Arnold said he would oppose that and would like to continue compensating the employee until his next doctor's appointment, which is early

next year. Trustee Arnold stated that if the claim goes to workers compensation it stays on the township's claim file for 4 years. Trustee Yoder explained that it has been a number of months that we have been doing the salary continuation, he knows there is some benefit to continuing this, but he does not think it is helping the situation.

19-411 Trustee Yoder moved the following resolution:

WHEREAS, the Board of Lake Township Trustees has entered into Salary Continuation Agreements with Brian Duman, the first commencing 07/31/2019; and

WHEREAS, in accordance with ARTICLE 33/Injury on Duty of the collective bargaining agreement between the Uniontown Police Department/Lake Township Board of Trustees and The Fraternal Order of Police, Ohio Labor Council, Inc., the employer may evaluate the circumstances of the case and may, at its sole discretion extend a salary continuation beyond the initial 90-day period or it may choose not to extend the Agreement.

NOW, THEREFORE BE IT RESOLVED, pursuant to the provisions as contained in ARTICLE 33/*Injury on Duty* of the collective bargaining agreement between the Uniontown Police Department/Lake Township Board of Trustees and The Fraternal Order of Police, Ohio Labor Council, Inc., the Board of Lake Township Trustees does not wish to continue/extend the Salary Continuation Agreement with Brian Duman beyond the current Agreement which continues to 12/12/2019.

## MEETING REPORTS/MISCELLANEOUS

- Trustee Yoder attended Christmas in the Village in Hartville. Ohio Magazine was there to recognize Hartville as one of the best hometowns in Ohio.
- Trustee Miller attended a training seminar about drainage put on by Stark Soil and Water. One of the items that was discussed was the drainage situation on the Oberg property. The Stark County Commissioner's off-road drainage program has been discontinued, Stark Soil and Water has taken that program over and unfortunately at this time they have no answers. There were not commissioners or attorneys representing them or the county in attendance at the meeting. Trustee Miller stated at this time the only thing he knows to do is to press at the state level to get the Ohio Revised Code (ORC) changed. He has already put in calls to State Senator Kirk Schuring and State Representative Reggie Stoltzfus to talk about this issue. In his opinion it is unfair, he

doesn't think it is being handled correctly but unless we get a change at the state level and get the ORC changed, he does not see it going anywhere quickly.

Trustee Arnold stated that he is being told Stark County is following suit with all the other counties in the state of Ohio, they don't do this. There are a few counties that have a tax collective for drainage, that is the exception, those counties do take care of the drainage. We do not have that in Stark County. Stark County was the only county that had a drainage program until this year. Stark County would partner with the township to work on these projects since they had the authority and protection to work outside the road right of way. Hundreds if not thousands of township residents benefited from this program before it was discontinued. The Township is legally not allowed to work on private property.

Trustee Miller said a tax collective was discussed at the meeting, outside of that there weren't any other ideas on how to address this situation. He is very frustrated with the lack of answers, but he will keep pushing.

Mr. Oberg asked out long does it take to make changes to the ORC? The Trustees replied it is a lengthy process. Trustee Miller suggested that anybody who has a drainage issue should be blowing up the phones of the County Commissioners and also calling your State Representatives.

Mr. and Mrs. Oberg stated how disappointed they are with the situation because it has affected their lawn, the foundation of their home and now they responsible for those repairs as well as the drain. If they pay to have a new storm drain installed and it breaks, they would have to pay to replace it again. If they should have to sell their house they would be unable to do so. Trustee Arnold asked if they talked to a contractor about a remedy and what they can do. They had a Civil Engineer come out, he told them what needed to be done. Mr. Oberg asked, easement or not, they can tear up the pipe and replace it? Trustee Miller told him he was correct. Mrs. Oberg wanted to know what standards had to be adhered to and who they should talk to? Trustee Miller said this was the argument that was made by multiple Road Superintendents, what if the homeowners don't do it right and it effects other homeowners up the line, who is liable for that. Trustee Arnold said if homeowners negatively impact people, they could be the subject of civil action. They should start with contacting Stark Soil and Water and Stark County Engineer's office.
