• The Board noted that the Springwater sign is less intrusive than a cluster mailbox. It also replaces the sign that was removed during the widening of St. Rt. 619.

21-389 Trustee Arnold moved the adoption of the following Resolution:

WHEREAS, Lake Township was informed that the Springwater Gardens allotment seeks to erect a sign in the public road right-of-way at the entrance of the subdivision to replace a sign that was previously erected in 1979 in the right-of-way controlled by the state of Ohio and was removed during a road construction project; and

WHEREAS, a representative of the allotment, Paul Gingo, has collected funds to replace the sign and relocate it within the Township road right-of-way; and

WHEREAS, the Township Zoning Regulations provide authority to the Board of Zoning Appeals to consider the type of style of a proposed allotment sign; and

WHEREAS, Mr. Gingo submitted a request for a conditional use permit for the erection of the allotment sign; and

WHEREAS, Mr. Gringo has proposed placing the new allotment sign within the Township controlled road right-of-way at the entrance of the allotment located on Williamsburg Avenue Northwest, from State Route 619, adjacent to Parcel No. 2203675; and

WHEREAS, on October 21, 2021, the Township Board of Zoning Appeals approved Mr. Gingo's proposed sign design and placement; and

WHEREAS, R.C. 5571.14 generally governs the authority of the Township Board of Trustees over right-of-way encroachments, nuisances and obstructions, and;

WHEREAS, R.C. 5571.16 authorizes the Township Board of Trustees to approve certain permits for the use of road rights-of-way, and;

WHEREAS, The Board has evaluated the circumstances of, as well as the nature and extent of, the subject sign encroachment and makes the following determinations. NOW THEREFORE, it is hereby RESOLVED by the Board that:

1. Under current circumstances, the proposed allotment sign does not qualify as a nuisance for purposes of R.C. 5571.14(A). The fence does not interfere with snow or ice removal from, the maintenance of, or the proper grading, draining, or dragging of the road, does not cause drifting of snow on the road, and does not otherwise obstruct or endanger the public travel of the road.

2. A roadway obstruction is ordinarily considered something that is a "hindrance, obstacle, barrier or an object that delays, impedes or hinders" travel or use of the road right-of-way. *Steigerwald v. Branagan*, 2008-Ohio-1528 (7th Dist.). Under

the current circumstances, the proposed sign, to be located within the right-ofway, does not qualify as an obstruction.

3. R.C. 5571.14 contemplates that encroachments within a township road rightof-way may be allowed to remain "on land belonging to a township road pursuant to a franchise or other grant of public authority." R.C. 5571.14(C). R.C. 5571.16 otherwise empowers a Board of Township Trustees to require persons to obtain permits for the installation of driveway culverts or making of other excavation or use of (including placement of any facilities within) a township road or road rightof-way.

4. The Board necessarily recognizes that its discretion regarding right-of-way encroachments is not unlimited. Thus, it has been observed that a Board of Township Trustees does not have authority to subordinate its easements for roadway purposes by means of granting a perpetual franchise or easement. 1980 Ohio AG LEXIS 68. Future circumstances may occur which could require more-expansive use of any given road right-of-way, whether for road relocation, widening, or other road improvement or right-of-way use by the public. A permanent or perpetual franchise or easement would, in effect, operate as a roadway vacation, and a Board of Township Trustees does not have authority to vacate any portion of a public roadway. Consequently, the authority of the Board in this instance is confined to extension of a license or permit, subject to the superior right of the public in the prospective future use of the right-of-way. 1980 Ohio AG LEXIS 64.

5. Consistent with its authority as set forth herein, this Resolution shall serve as a revocable permit extended to Paul Gingo for the sign, as approved by the Board of Zoning Appeals, to be placed within the public road right-of-way at the entrance of Springwater Gardens allotment, located on Williamsburg Avenue Northwest, from State Route 619, adjacent to Parcel No. 2203675, subject to any future determination of the Board of Trustees.

7. The revocable permit represented by this Resolution is subject to the discretion of the Board and, consequently, may be revoked at any time upon any determination of the Board causing such revocation.
