If you are aware of a home that appears abandoned or has tall grass or weeds growing on the property, please contact the Lake Township Offices (330.877.9479) so that we may initiate contact with the bank or lienholder. Early notification helps to ensure that the banks will maintain these properties and also helps to prevent possible damage to the structures if they are not winterized or are unsecured.

Also, if you believe someone is at the property who should not be there, please contact the Uniontown Police Department (330.699.6444), or Stark County Sheriff (330.430.3800), depending on your district.

# GENERAL ELECTION IS NOV. 3



All Lake Township voters will vote on two Township Trustees in the General Election on Tuesday, November 3.

Township voters outside the Village of Hartville will see Issue 30, a 1.25-mill, five-year, renewal levy for emergency medical services on the ballot.

Renewal means no increase in the tax.

Voters in Precinct 3 only will consider Issues 38 and 39, local option for the sale of alcoholic beverages at Seven Hills Country Club.

Voters in the Village of Hartville will vote on four Council positions.

Three seats on the Lake Local Board of Education will be on the ballot, but no levy this time.

Voters in the North Canton City Schools district will vote on three Board of Education positions, but no levy.

In the Plain Local Schools district, there will be three Board of Education positions on the ballot, but no levy.

On the ballot county-wide are Issue 4, renewal of a 1.4-mill levy for support of children's services, and Issue 5, repeal of the county permissive sales tax of 0.5 percent.

Three state-wide issues are on the ballot. Issue 1 is a constitutional amendment authorizing the State of Ohio to issue bonds to provide compensation to veterans of the Persian Gulf, Afghanistan and Iraq conflicts.

Issue 2 is a constitutional amendment to create an Ohio Livestock Care Standards Board to establish and implement standards and care for livestock and poultry.

Issue 3 is a constitutional amendment to allow casinos in Cincinnati, Cleveland, Columbus and Toledo.

A new school year is underway. Motorists should watch for school buses stopping, and be aware of school zones and children running around.

Reminder to residents: our records show that 99 percent of vehicle break-ins are to unlocked vehicles. It's a good idea to lock your vehicle even when it's parked in your own driveway.

Our officers will conduct the "Shop with a Cop" program again this year, where at Christmas time they will collect donations from businesses and the public. The monies received then go to children whose names are obtained from elementary schools, not only in Uniontown, but also from Hartville and Greentown.

Starting this year, our officers will participate in the "Fill a Cruiser" project. This involves collecting food at Thanksgiving, which will then be given to residents of Lake Township who are in need. All these programs are done on the officers' own time.

Your Board of Trustees has placed a renewal of our current EMS levy on the November 3 general election ballot. Renewal means we are not asking for an increase in your taxes. We want to continue our very fine emergency medical service for another five years at the same rate.

This summer, Lake Township re-paved 12.05 miles of township roads. We rebuilt or replaced 37 catch basins and installed more than 1,043 feet of curb and gutter.

We are prepared for whatever winter brings. We've already arranged to purchase 4,500 tons of road salt through the Stark County Cooperative Purchasing Program, so we should have plenty of salt. Let's hope we don't need it!

Residents of the unincorporated area of Lake Township who are interested in service on this Board may pick up an application at the Township office during business hours (Monday through Friday, 8:00 AM to 4:30 PM).

Candidates must be able to attend at least one meeting per month.

The purpose of the Zoning Commission is to hear requests or applications for zone changes, amendments or supplements to the Zoning Resolution, and to make recommendations on approval or denial of those requests to the Board of Lake Township Trustees.

Members are paid \$35.00 per meeting.



## STORMWATER PROTECTION NEWS

From the Stark County Health Department

Many homes throughout Stark County have a type of septic system that requires the use of an aerator. There are many types of aerators in use, but all follow the same basic principles.



1. An aerator requires the use of a motor to bring air into the system and create good bacteria known as aerobic bacteria. These bacteria break down sewage, producing a clean effluent. If you have an aerator, check often to ensure that the motor is running properly. You should be able to hear your aerator when standing beside it, and you can also feel vibrations if you put your hand on it.
2. An aerator cannot do its job unless it is turned on. With little exception, aerators are designed to run continuously and should not be turned off or allowed to run off of a timer. An aerator that is not permitted to run is most likely discharging raw sewage and is a hazard to public health. Accordingly, this would also be a violation of state and local laws.
3. A properly functioning aerator also requires regular maintenance. Service contracts are available from the aerator's registered service provider(s). A list of registered service providers is available at <http://www.starkhealth.org>. Remember that even with the motor running, lack of maintenance will cause the system to discharge poorly treated effluent.
4. Never bury your aerator lids. The lids are necessary to access your aerator to perform maintenance, and also important to bring air into the aerator which sustains the good aerobic bacteria.

Within the Stark County Health Department's Phase II Stormwater Program, septic systems (including aerators) are being checked to ensure that they are functioning properly. This includes confirming that the motor is running, the effluent quality is acceptable, and the system is operating as designed. If you have any questions regarding your aerator or septic system in general, please contact the Stark County Health Department and ask to speak to a Phase II Stormwater Specialist.

# RECYCLING AND YARD WASTE PROGRAM

Lake Township Trustees, in recognition of the environmental benefit of recycling and yard-waste collection programs, have provided a site as a convenience for township residents' use all year round. The Recycle Center is located on Midway St. near the Township Service Building. The Township pays employees at least thirty hours per week just to keep up with the yard waste.

Some people have been abusing the program, leaving such items as fencing, railroad ties, a drafting table, and even a swing set right beside the sign that lists acceptable items. The additional costs resulting from this dumping of unacceptable items has created a financial burden for labor and disposal. An ongoing investigation is being conducted to find out who has been dumping these materials. Trustees have asked the Stark-Wayne-Tuscarawas Joint Solid Waste District and the Ohio EPA for assistance.

Lake Township Trustees recently added the Midway St. Service Complex to the jurisdiction of the Uniontown Police Department. Police officers regularly patrol the property. Surveillance cameras will soon be installed.

The Township provides an annual Spring Clean-up program in June for residents to dispose of items such as appliances and tires.

Thank you for your cooperation in the proper use of our Recycle Center and Yard Waste Collection site.

## DID YOU KNOW?

Lake Township has six ZIP codes, five telephone exchanges, three school districts (Lake Local, North Canton City, and Plain Local Schools), three police protection agencies, three volunteer fire companies, two local government entities, and only one incorporated municipality (the Village of Hartville).

It is a curiosity of Ohio law that all residents of the township, including those living in the Village of Hartville, vote for the township trustees. Only those outside the incorporated area, however, vote on township tax issues such as road levies and fire levies. The village has its own tax for fire and emergency services.

## A Word from Your Fiscal Officer:



## MEET OUR FIRE & EMS



A Lake Township Trustee has said many times, “We have the finest fire service in Stark County.” Lake Township enjoys professional fire and emergency service from three private fire companies: Hartville, Uniontown and Greentown. They have the township divided into service areas, covered by four stations. Residents don’t have to worry about which one to call, though. A call to “911” will bring the right one. All of the fire companies have mutual-aid agreements with one another, and with neighboring communities. That’s why equipment from more than one fire company is sometimes seen at some emergency scenes.

First-response EMS service is provided by each of the fire companies. All three have fully-trained EMT’s and paramedics on duty around the clock.

It’s important to remember that the firefighters and paramedics are not employees of local government. They are our neighbors, and many of them are volunteers. All three fire companies have paid staff to man the stations when the volunteers are working at their career jobs.

Each of the fire companies is a separate, licensed, private, non-profit Ohio corporation which provides service under contracts with Lake Township, financed by revenues from tax levies. The fire companies do some fund-raising of their own, as well as applying for grants for training and similar purposes. All three companies own and maintain their own buildings and equipment.

The Hartville Volunteer Fire Department, formally incorporated in 1935, has served the Hartville area since 1900. They serve the eastern half of Lake Township with two stations. The Uniontown Volunteer Fire Department was organized in 1947, and the Greentown Volunteer Fire Department in 1949. Together, our three fire companies have served this community for a combined total of more than 200 years. Some years ago, Lake Township Trustees said of the fire departments, “The fire-fighting companies...have saved countless lives, protected property and saved taxpayers substantial dollars...These hundreds of fine men and women have...literally put their lives and well-being on the line for all residents of Lake Township.”

## A REMINDER FROM THE ROAD DEPARTMENT

Snow is coming soon. Here are some things to keep in mind when the snow falls:

- Never park your vehicle on the road during a snowstorm. This can create a traffic hazard for the snowplow operators. It could result in that section of the roadway not being plowed. Please move your vehicles into your driveway during a snowfall.
- Check your mailbox to make sure it’s not extending over the road surface.
- Please take your trash cans in from the street as soon as possible after your trash has been picked up, so streets can be cleared of snow.
- Never push snow from your driveway into the street, especially after the roads have already been plowed and salted.
- Please be considerate and give the snowplow trucks plenty of room.
- When bad weather hits, plan your trip to allow for extra time.
- Listen to WHBC (94.1 FM or 1480 AM) for messages on township parking bans.

Daylight Savings Time will end on November 1. Please remember to replace the batteries in all of the smoke detectors and carbon monoxide detectors in your home when you change your clocks.

Don't burn your leaves! Please take them to our Yard Waste drop off site, located behind the Recycle Center at 1505 Midway Street, next to the Lake Township Service Garage.
